Established: 1970, by amended Taylor Act

Abolished: ca. 2006? Last reference to found in 2006 League of Women Voter's directory

3 members serve 6-year terms, appointed by the County Executive and confirmed by the Board of Legislators; no more than two board members from the same political party. Members are paid \$100 per diem plus expenses not to exceed \$3000 total per annum.
